Once appraised at more than \$90 million, the former Lochmoor Country Club and Golf Course, now known as Paradise Preserve, was purchased last Friday by a subsidiary of California-based Brandenburg Properties for \$3 million.

The property sits at the end of Orange Grove Boulevard in North Fort Myers near the border of Cape Coral, and has stood vacant for numerous years.

All that remains active in the complex is Paradise Marina, which is now under new management.

Neighbors who live adjacent to the approximately 400-acre site are expressing excitement over the sale, and what it can mean to the
